

First ship docks at Port Daniel terminal


GASPÉ: - The first ship to dock at McInnis Cement's marine terminal, the Algoma Mariner, arrived at 4 p.m. on Thursday, November 24.

The ship, a bulk carrier, delivered 19,000 metric tonnes of gypsum that had been loaded at the port of Halifax.

Gypsum is an important input used in the production of cement. Before Christmas, five more ships are scheduled to deliver other inputs. The first delivery of cement is still scheduled to occur in March 2017.

"The docking manoeuvres took 35 minutes. Usually, for a ship of that size in a similar marine terminal, it should take 45 minutes to dock the ship. The team is therefore very satisfied with the way the operation was carried out, considering that it was the first time," explains Maryse Tremblay, spokesperson for McInnis Cement.

The unloading operations started at 7 p.m. and were maintained on a continuous basis, day and night, until the morning of November 26. The conveyors located on the wharf unloaded the ship at a pace of 800 tonnes per hour.

The Algoma Mariner is a Canadian bulk carrier equipped with self-unloading

The Gaspé will benefit from new immigration policy

GASPÉ PENINSULA: - The Gaspé Peninsula fits perfectly in the 2017 Quebec Immigration Plan's objectives, reassures Québec's Immigration Minister, Kathleen Weil, in an interview with Spec.

For those who are familiar with the new policy, you will have noted that one of the objectives reads as follows: "To contribute, with the collaboration of local economic and territorial decision makers, to the development of Québec's regions through permanent and temporary immigration."

Spec reached Minister Kathleen Weil to get a clearer picture on how the Gaspé Coast could fit in that perspective. When asked if her policy really has the intention of encouraging people to immigrate to our region given that 90% of new immigrants stay in Montreal. She replied "You're at the heart of the position we want our policy to have in terms of regional immigration, which of course includes your beautiful region, the Gaspé Peninsula," she pointed out. She adds that, "The immigrants are mostly qualified workers, humanitarian immigrants and immigrants who want to join their families. "In your region, the immigrants are composed of 50% qualified people and 50% of family gathering people," affirms Minister Weil.

The immigration policy's approach is different from the previous one that was based on first-come, first-served. This time the policy is based on the immigrant's competence that meets the needs of this or that region, she says. "We favour this new approach in collaboration with every region's Workplace Partners Committee and with Emploi-Québec. Therefore, we invite immigrants to submit their

candidacy as quickly as possible and then we can link that immigrant and his competence with a region or a business."

Thousands of jobs available

The advantage with this new operating method is that it will allow the Workplace Partners Committee of the Gaspé Peninsula to count on a broader picture in terms of regional job opportunities and the workforce availability, adds Minister Weil. "We know that in your region, there's a great need in many trades, such as butchers, master and assistant mechanics, nurses, civil engineers, carpenters, electricians and so forth. All in all, in the next three years, 10,400 jobs will be available. This is an important issue in the Gaspé as you know," she said. Of these jobs, 9,500 will be made available because people will retire.

Villa James is back on track

PERCÉ: - The mythical Villa James, dating back to the 19th century, overlooking Percé Rock will reopen its doors to students and the local community next summer. Owned by Laval University (Québec City), the heritage house offered arts, design and architecture master classes in the summer season from 2002 to 2014. For financial reasons, the school establishment had to put a hold on the seminars and classes. The good news is that Villa James is reopening starting next summer with a new approach which is based on the collaboration of the local and regional community and organizations, confirms the spokesperson of the University, Nicole Lacasse. "We've recently gathered 25 people to see how we could relaunch the activities with the community and the response was there. Our classes will be adjusted to the needs of the area, such as Percé's biology, forestry, fisheries and so forth. We will of course continue to offer arts and photography classes." The complete 2017 program of the Villa James Summer School will be published in the coming months.

LM Wind Power plant expanding

GASPÉ - LM Wind Power has begun a significant expansion of its Gaspé plant. There has been heavy machinery working on the north side of the facility since November 22, even though the company has not yet announced anything and will not confirm details about an expansion.

The management of the company confirms the evidence, "that there is machinery" working on the plant's premises. The SPEC saw a fair number of workers operating that machinery to excavate and prepare the foundation of a new building. Some workers were also installing fences to mark off the construction zone.

"LM has always said that the growth of the Gaspé plant was a priority for the business. It is definite that some growth projects are planned by the management of LM but we can't divulge the details," specifies Alexandre Boulay, the plant's director general.

The dimensions of the new building, the amount invested and the number of new jobs created have not been revealed by the company. Alexandre Boulay admits that the company is currently hiring. In August the firm had announced the addition of 85 positions to the 200 the Gaspé plant already employed. "We have surpassed 285 jobs. We presently have 300 people employed at the plant. We hired people as recently as Monday (November 21). We are always looking for new workers to support the development of the plant," he says.

details about the project. The expansion evidently is aiming at increasing the blade manufacturing capacity of the plant. Since September 19, the Gaspé employees have been working at full capacity to fill a giant export order for turbine builder General Electric. That contract occupies the whole plant. The blades are replacing units that were installed in wind mills mainly located in Texas.

LM Wind Power is negotiating another siginificant blade supply contract, also for export purposes. Alexandre Boulay hasn't confirmed those details but he points out that "we still have elements to secure." The company will be ready for an announcement "in a matter of weeks or months," he adds cautiously.

On November 18, Gaspé riding Member of the National Assembly Gaétan Lelièvre said during a press conference on the necessary improvement of rail services, that an expansion of the Gaspé plant was a short term possibility. He was talking about the possible creation of 100 jobs.

On November 23, Mr. Lelièvre said that he didn't know much more about LM's project. "I can see the construction site when I pass there; I notice that there is foundation work." paid by General Electric (GE) and its customers by close to \$800,000.

The Matapedia-Gaspé line has belonged to Quebec's department of Transport since the spring of 2015. It is only functional between Matapedia and Caplan, a tad more than one third of its whole length.

The Caplan-Gaspé stretch was put in a dormant state by Transport-Québec in 2015 because some repairs are needed. The last amount earmarked for the line infrastructure was announced by the Quebec government in 2013. The total cost of putting the line back in a fine state varies according to the scenario chosen but it will amount to tens of millions of dollars.

In the meantime, all the transportation requests sent to the operator of the line, the Gaspésie Railway Society, are related to the dormant portion of the line. They total thousands of carloads annually. A number of organizations tied to the economic development of the Gaspé Peninsula are asking the Quebec government to allot the money required to repair the line. Most of the work would be concen-

Police report



The Sûreté du Québec is investigating a case of mischief on a vehicle belonging to Michel Méthot, a former municipal councillor of the town of Percé. The vandalism was committed during the night of November 23 to November 24 on the property of Mr. Méthot. The jeep's lights and some windows were smashed and extensive damage was caused to the rear section of the vehicle.

Such a mischief is not unusual, except that Michel Méthot was a member of a town council that was caught in the turmoil of the November 20 referendum regarding the projected construction of a \$1.77 million commercial street in the downtown area of Percé. Mr. Méthot campaigned with another councillor, Robert Daniel, in order to convince the residents of Percé to reject the project, which they did.

Michel Méthot thinks that his 2006 vehicle is totalled, but was trying to minimize the incident when interviewed by the SPEC.

"It is just an old jeep that was damaged. It was not new. It is only a jeep I use to go hunting. I don't know who did it. It is someone who doesn't like me. Half of the population doesn't like me and the other half likes me. In fact, more than half of the population likes me because the "no" option received 200 more votes," says Mr. Méthot.

Mr. Méthot operates a bed and breakfast on Cap Barré Street, located near the church. He didn't hear any noise during the night. "I was sleeping in the basement, as we leave the upper rooms for our guests. We can't really hear anything in the basement. The property is big and we live close to the woods." He is not certain that the vandalism was perpetrated by people frustrated by the referendum results.

He, nonetheless, observes mounting tension in the Percé area since the referendum. "Facebook is poison and deforms everything. It is easy to criticize that way," he says referring to a number of anonymous people commenting on the aftermath of the referendum.

Sûreté du Québec spokesperson Sgt. Claude Doiron refuses to comment on the investigation. "We are not entitled to comment on an ongoing investigation (...) in order to protect the integrity of the police inquiry."

The first session of the Réal Savoie murder trial will in all likelihood last at least the five scheduled weeks at the New Carlisle courthouse. Defence attorneys Marcel Guérin and Reginal Victorin were expecting a shorter session after three days of hearings, but are now sure that the five weeks of hearings will be necessary. trated on reinforcing some bridges.

The export contract signed so far by LM Wind Power will be valid for at least three years, quite possibly more. The first blade transportation contract awarded to the Gaspésie Railway Society calls for the hauling of 600 blades to Matapedia, where other railways, Canadian National among them, will take the unit train and deliver it down south.

Because of their length of 42 metres, the 600 blades will require the use of 900 flat cars



"The examination and cross-examination of the witnesses is longer than expected," pointed out Marcel Guérin. On Tuesday, November 22, the proceedings were postponed until November 28, which will be the trial's fourth week.

Made In..... The Importance of buying local

The SPEC'S recent introduction of this series has provided an opportunity to introduce readers to local businesses, entrepreneurs and creators from the Gaspésie.

As a contributor to that series, I was recently asked the question, "Where are you finding these people?" in reference to some of the colourful characters and creative businesses that have been profiled over the last few weeks. The truth is, they all found me in my effort to shop locally.

In my home, particularly since my children have become consumers themselves, we use a simple purchasing "philosophy". That is, when we choose to buy food, articles of clothing, household items or if we need services we:

Buy used, or buy locally. If what I want is not 1. available or cannot be found we....

Seek out the product or service regionally. 2. More often than not, that works, but if we get stuck we....

Try to find what I need provincially. If we can't 3. find what we are looking for in Quebec, we figure we can do without it.

The choice to buy locally is of course up to the individual but in my case it is rooted in some personal priorities. When I buy locally grown or produced food it is simply better for my health. Local food is fresher and many of the products that I buy are organic or are raised using organic practices. For me, local food is the best choice for my family.

As for the rest of my reasons for buying locally, the list is long and varied: To diminish my impact on the environment, to stimulate the local economy, to help create jobs and opportunities, to build community and more. If that seems like an awful lot of thought to put into the purchase of a loaf of bread or a winter jacket, rest assured that with time, shopping this way becomes a habit and requires no thought at all and only minor effort.

For one, I must think ahead. If I am travelling between towns on the Coast, I do a quick mental check of the businesses and suppliers that I might need or want to see on my way in order to make sure that I don't waste a trip. As for food purchases, I ask my grocer to carry local products (trust me, grocers want to know what you want to buy) and I buy directly from local farmers and markets as much as I can. In the winter months. I subscribe to a local food service where I pick up my fresh local products every week.

Keep in mind that buying locally doesn't always mean buying from mom and pop shops. I still buy products from stores like IGA, Canadian Tire or Rossy's – after all these are local businesses too, but they are my second choice to smaller businesses when I have the option.

In addition to shopping locally at home, I have also become a local consumer when I travel or visit outside the region. I have been thrilled to discover amazing local products and creations in Charlevoix, Kamouraska, Montreal, Brome-Missisquoi, among others. The impact of my dollar on local businesses outside the region is just as important as those that I spend here at home.

As we all know, the minute the clock strikes 12:01 a.m. on November 1, we are officially allowed to discuss Christmas. In the coming weeks, you will probably be spending more money on non-essential items than you do any other time of year.

Spending some of those dollars in local businesses or at a local Christmas bazaar or on a local product will have a far-reaching impact. Over the last few weeks I have seen that effect directly, not just on individuals or families but on entire communities that benefit from the presence of local businesses.

Keep in mind, local businesses pay taxes to the province which benefit us all. Small business owners remain in the region and raise their families here. Our friends and neighbours are employed in those businesses. Our dollars are spent locally, helping to stimulate the local economy and sales tax that is collected contributes to our communal wealth. While I realize that sometimes a "deal" is hard to ignore, when you order from Amazon or drive your dollars to New Brunswick to buy at Walmart, no one garners the benefits of local consumption and ultimately it only contributes to the bottom line of a big corporation.

Where we chose to spend our money is as important as any vote we have ever cast. The way that we spend our money as Gaspesians, can greatly influence our communities and our society and has a potential to influence change everywhere. Whatever you buy, whatever is sitting in your shopping cart waiting to be scanned is voting YES to more of it.

Movie Theatre, New Carlisle - 1940's.

I was very interested to read in the October 26, 2016 issue of the Spec about the old movie theatre in New Carlisle which was demolished in October 2016. Town Hall records indicate the building may have been built in 1960, but it is suggested by the town administrator Denise Dallain that it was built before that. I can relate to that because I know from firsthand knowledge that the original building existed in the 1940s, during the war. It was built sometime before that.

During the 1940s, this building was a movie theatre, nothing else. I used to attend movies there during the war in the early 1940s. During the years 1946 to 1951, my brother George and I and my sister Jean sold all the tickets to all the movies in this same building.


The original building was built with two stories at the front facing the street, in the usual rectangular shape. The main floor was the entrance area including a ticket sales wicket and two stairs which were the entrances into the theatre. Through a doorway at one side was the stairway to the projection room on the second floor.

The rear two-thirds of the building had the shape of a 180 degree curve, like a large Quonset hut (with a semicircular cross section). Overall, it was an odd configuration, looking from the outside, almost like two different buildings with two different shapes, pushed together. That is the way the building was when I was transferred away from New Carlisle in 1950.

I am told that the theatre portion (in the shape of a Quonset hut) was rebuilt later to provide offices and took on a more conventional shape overall. Maybe that construction took place in 1960, the date found in the Town Hall records.

The location was across the street from Lee Caldwell's General Store (now the Heritage Restaurant) and it was next door to the home of Mr. J.B.S. Mitchell and family. He was the Superintendent or General Manager of the Canadian National Railway operations for the Gaspe Coast. At the present time, the main floor of this (Mitchell) building is the location of the Gaspé Spec newspaper

In the 1940s the movie business was operated by Atlantic Amusements Company Limited, which was owned by Mr. Dubreuil, who was General Manager of the Bonaventure and Gaspe Telephone Company at the time, located in Paspebiac. That much I know for sure. Likely Atlantic Amusements owned the theatre building as well, but I cannot confirm. We used to think that Mr. Dubreuil owned the B & G, but I cannot be sure about that

The job included having custody of the cash box, opening the theatre a half hour before movie time, selling the tickets, balancing the money with the number of tickets sold, making up the bank deposit (at home), depositing the money in the bank account of Atlantic Amusements Company Limited on the next business day, and copying all the information to give to Mr. Dubreuil. And - oh yes - the job included sweeping out the entire theatre with a broom after everyone had left and locking up the theatre for the night. For all that, I earned \$1.00.

Town of Gaspé and Percé Rock MRC request rail service to Gaspé

GASPÉ: - Gaspé Mayor, Daniel Côté, Percé Rock MRC Prefect, Nadia Minassian, add their voices to those of numerous stakeholders requesting investments from the Ouebec government in order to reopen the railway as far as Gaspé, and as soon as possible.

The statement was presented 10 days after a similar position was expressed on November 18 by the two MNAs representing the Gaspé Peninsula, Sylvain Roy of the riding of Bonaventure and Gaétan Lelièvre, of the Gaspé riding.

Mr. Côté and Ms. Minassian are aware of the rumour that the Quebec government is preparing an announcement about the Gaspé Peninsula railway. However, that announcement would only pertain to line improvements between Matapedia and Caplan, which is the section currently active, or Matapedia and New Carlisle.

"Any investment will be welcome but is it possible to conceive and revive that file while taking into account the solution that will bear the highest results possible? (...) We could have refrained from organizing a press conference and let the government make its announcement that might have included a passenger train down to a certain point. We have instead decided to make our position known," pointed out Nadia Minassian.

Rumour also has it that the amount of money that could be allotted for the Gaspé Peninsula line would be in the range of \$50 million.

At least three times during the press conference, Ms. Minassian begged the Quebec government to consult the stakeholders of the Gaspé Peninsula. "We don't like signing a consent on something that doesn't fill our needs perfectly," she said, referring to the optimal use of the amount of money the Quebec government could hand out. Mayor Côté used other words to send the same message. "Can we rebuild a (transportation) model that will optimize our needs? We are in a position to haul the LM Wind Power blades over the short term, and McInnis Cement's products soon as well. A number of other enterprises have made requests to ship by rail (\dots) We cannot identify them for now but they are very serious." LM Wind Power will haul 900 cars over the next year to

Gilles Gagné ship 600 windmill blades to the United States, a traffic that will likely increase over the spring of 2017 with an expansion of its Gaspé plant. The flat cars are loaded in New Richmond for now because the line east of Caplan is dormant, thanks to the Transport-Québec decision.

> A customer, who remains unidentified for now, is also interested in shipping the equivalent of 5,000 carloads originating from Gaspé. Daniel Côté mentioned that another serious customer has expressed a interest in using the railway from Gaspé.

> Nadia Minassian says that the situation has also changed recently in her MRC, hit hard economically since the closure of the Gaspesia paper mill in 1999.

> "There are new needs for transportation. We have no choice. I cannot talk on behalf of McInnis Cement but the company management has always said that they will use the railway if it is available. All the investors interested in settling in Chandler's industrial park or in the industrial zone of Port

Daniel are asking the same question. "Will we be able to use the railway?" It is a must," she states.

"There is a new industrial effervescence in the Gaspé Peninsula right now. We were plummeting for years but now, we are emerging again. There is one missing tool, the most competitive tool and that is the railway," adds Daniel Côté.

Depending on the amount earmarked by the Quebec government for the Gaspé line, there might not be enough money to bring the passenger train back to New Carlisle and get the freight train down to Gaspé simultaneously. The Quebec government has owned the Matapedia to Gaspé line since the spring of 2015.

"We think that bringing the freight train to Gaspé comes first. It is likely to save the line," says Daniel Côté.

"The norms are more strict for passenger trains. It will be easier to bring the freight train back in the short term and work on the passenger train soon

PERCÉ: Mayor and six councillors resign

Lelièvre wants an election in Percé before the end of winter

PERCÉ: – The Gaspé riding Member of the National Assembly, Gaétan Lelièvre, has asked Quebec's Municipal Affairs Minister, Martin Coîteux to call an election before the end of the winter in Percé. Mayor André Boudreau and five councillors resigned on November 20 and 21 following the result of a referendum.

The six council members left after seeing that the project of building a commercial street in the downtown area was rejected by 953 electors, and approved by only 745 people. The project would require a loan of \$1.77 million.

Gaétan Lelièvre met with Martin Coîteux on November 22 to ensure that he understood the importance of not leaving Percé without a municipal council for close to a year with a wide array of projects on the table requiring upcoming decision-making.

"Had the resignations occurred two weeks ago, an election would have been called. We only reached the one-year period by a few days separating us from the 2017 municipal elections. The minister can call an election under those circumstances," points out the Gaspé riding Parti Québécois Member of the National Assembly.

In fact, technically, a private bill usually has to be submitted for approval when one wishes to defend the necessity of calling an election when the delay between the by-election and the general municipal election is less than a year. The next Quebec-wide municipal election is scheduled for November 5, 2017. A private bill requires the intervention of a "godfather," someone who will write the motion and submit it to the National Assembly for adoption. On November 24, the Commssion municipale du Québec, Quebec's body that usually deals with situations similar to Percé's, appointed Administrative Judge France Thériault to administer the town's affairs and guide the employees. It was a necessary step because the six resignations means that there is no longer a quorum. The three remaining councillors would have to submit their candidacy again, if an election is called. Mr. Lelièvre, who has worked in municipal affairs for many years, explains that Page 6, November 30, 2016 - Spec

Percé's large files, like the wharf repairs, the reconstruction of the boardwalk and the protection of the shoreline, are at risk of stagnating.

"The administrator of the Municipal commission does interim work. Based on my experience, I can say that the large files will not progress. The government will say: We will wait until we have a municipal council before making a move. However, Percé cannot afford to wait," explains Mr. Lelièvre.

The wharf needs urgent repairs as each storm can make it non-functional. Its repairs could cost between \$8 and \$10 million. The boardwalk must be rebuilt and protected, two steps that could translate into an investment hovering between \$15 and \$20 million. "If we postpone those proj-

ects, they will still be presented as electoral promises in 2018 instead of appearing on the list of accomplishments. The people are entitled to have a municipal council. It is a regional stake, considering the importance of Percé in tourism," says Mr. Lelièvre.

On the other hand, he believes that an election cannot be rushed.

"Tensions are still very high. The dust must settle. The citizens must prepare themselves and find leaders. The Christmas break will be a good time for reflection. I think that the end of February would be fine for an election if an election is called," concludes Mr. Lelièvre.

The Town of Gaspé to consult the population about the arena

GASPÉ – The Town of Gaspé will consult the population during the spring about the project to build a new arena. Discussions about replacing the older downtown arena have occurred off and on over the years.

At one point, the municipal administration was considering putting a new arena in the Saint-Majorique area to replace the downtown and the Rivière-au-Renard buildings. That idea was dropped, as people from the communities around Rivière-au-Renard didn't like the idea of losing their arena and travelling 20 kilometres to reach the new one.

The current scenario would situate the new building in Wakeham on the site presently occupied by Transport-Québec's garage and maintenance centre.

"The new project is really at an early stage. We cannot talk about a cost or even an accurate scenario. We can say that there will be thorough public consultation during the spring to design the project with the population," explains Jérôme Tardif, the Town of Gaspé's communication officer.

"Moving Transport-Québec, the decontamination of the soil and the demolition of the Transport-Québec buildings will not be completed before 2019. So we cannot think about construction before 2019-2020," adds Mr. Tardif.

PERCÉ: - Véronique Lambert, is a prize winning graphic designer who has practiced her trade since 1996. In 2007, after her return to the region, she began creating, sewing and printing her Faite Icitte products. The term Faite Icitte is a tribute to the Québecois coloqualism meaning "Made Here".

Her inspiration for the name of her product line was born of her four-year stay in Switzerland. Many with whom she worked and socialized found differences the between Québecois French and Swiss French amusing, and she felt the same. Despite speaking the same language, she felt that at times the conversations she was having required subtitles and she decided then that one day, she would use those lanuct line included t-shirts and bags emblazoned with the Faite Icitte moto - 'Mon t-shirt est faite icitte,' 'Mon sac est faite icitte,' however before long Véronique Lambert's products also became influenced by local history and cul-Véronique Lambert ture. began to tag her creations with Quebec's official "Je me souviens" motto and developed aprons adorned with a recipe for Quebec's unofficial dish, the poutine. Later, a line for babies entitled "Je suis faitte icitte" (I was made here) was also added. This past summer she developed a product line called L'isle Percée written in old French which is a series of nautically styled bags whose name was inspired by the historical story of the Percé region. In all, her product line includes a dozen different products and models.

Orginally sold excusively at the two Macareux gift boutiques in Percé, the product line proved to be very popular, especially with European tourists

challenges that have been born of her success. She has received requests to supply stores in Quebec City, Drummondville and Montreal among others. At the outset, Faite Icitte products were being produced in small, handcrafted batches, however the demand for her products has forced her to consider a more commercial expansion – a concept which is difficult considering what her original intention was. "I used to use recycled materials that were locally sourced from Grande Rivière, however that company has since closed. Considering my message, I cannot begin to print designs with a commercial printer on a Fruit of the Loom t-shirt made in the U.S.A.," explains Véronique. She is on her way to finalizing a deal with Arseno, a printing group out of Matane that will be able to provide Quebec made t-shirts adorned with Véronique's graphic designs. Other 1 materials such as the aprons and pillow covers will continue to be made by hand in Percé. NOVA LUMINA IN CHANDLER: A remarkable success for its first year



CHANDLER: - Nova Lumina, an attraction located in Chandler, that was developed over the spring and opened in mid-July, was a major success in 2016, not only by Percé Rock MRC standards, but by Gaspé Peninsula standards, as 27,572 people visited the lights and sounds show.

Nova Lumina is set-up in the trails of the Bourg de Pabos archeological site, on the Pabos Mills side of the Grand Pabos and Pabos West rivers. It comes to life at night and depicts the historical, contemporary and past, situation surrounding Chandler, station-by-station animated by state-of-the art equipment, including a "magical" stick given to each visitor.

In two-thirds of a season, from mid-July to October 1, Nova Lumina attracted as many people, as the other popular Gaspesian attractions that have been around, in some cases for a decade or more, like the Bioparc in Bonaventure, Exploramer in Sainte-Anne-des-Monts and the Musée de la Gaspésie in Gaspé. Those attractions charge an entry fee in the same range, often around \$20 per adult.

"It went very well. We already see things that can be improved. A couple of factors hampered the attendance, like the number of sticks available for the visitors. We had a capacity of 100 people per halfhour, which was not enough. We bought more sticks and

were able to increase our capacity to 200 people per halfhour," explains Nova Lumina director Émilie Bourque-Bélanger.

"I was only hired on April 4. We had very little promotion time. A lot of promotional work is done during the fall. I see that this year. We are preparing the summer of 2017," she adds.

Installing the Nova Lumina equipment took one month, from mid-June to mid-July. The operation was carried out by the conception company in charge of the project, world famous Moments Factory, and local technicians. That came after two-and-a-half months of trail work by local teams. Moments Factory is based in Montreal and has organized

Super Bowl intermission shows.

Émilie Bourque-Bélanger is confident of having another excellent season in 2017, even though Chandler's Centennial was favourable for the 2016 season.

"We will improve some aspects, like the interaction zones. The story and the stations will remain the same, overall," she says.

It took three weeks, starting at the beginning of October, to dismantle the sound and light system in order to protect it from the elements during the cold weather.

Nova Lumina required an investment of \$2 million. It was funded by Chandler's Economic Diversification Fund, founded during the dismantling operation of the Gaspesia mill, and by various Quebec government departments, including Tourism, Municipal affairs, Economy, Science and Innovation and Emploi-Québec. The Gaspésie Tourist Association and Canada Economic Development also funded it.

after that," says Nadia Minassian.

The Gaspesian stakeholders are supported by at least two Quebec-wide organizations, the Conseil du patronat (the Employers Council) and Manufacturiers et Exportateurs du Québec, a group representing the province's manufacturers and exporting enterprises.

The amount of money required to increase the bearing capacity of the line between Matapedia and Gaspé hovers around \$86 million, according to a Canarail study conducted in 2014. That amount would imply the replacement of the two bridges spanning over the Grand Cascapedia river and bringing the passenger train to Gaspé.

Windmill blades are very light by railway standards and their hauling would not require massive investments for now between New Carlisle and Gaspé.

The Quebec department of Transport has so far snubbed the Canarail study, preferring to rely on a previous document stating that \$120 million would be needed to increase the capacity of the entire line. The Quebec government has not invested any money in the Gaspé line infrastructure in 2014, 2015 and 2016.

The former owner of the line, the Gaspésie Railway Society, has remained the operator of the freight train since the Quebec government took ownership of the railway, between March and May 2015.

Just Passing Through

In the winter I recall my grandfather going to cut and bring logs out from Number 12 Road, a road that still exists in New Carlisle today.

In the early morning he would leave with his two horses and two sleighs loaded with two feed bags for the horses, along with his packed lunch and a thermos of hot tea for himself. There were two sleighs and two horses but only one driver. My grandfather would drive the first horse back to where he would cut wood and the second horse would follow dutifully behind without being tethered.

Back then, winters were much harder than they

are today. There was so much snow years ago. Back then, a majority of the farmers made their fences from cedar rails, which they would cut by hand in the woods. The farmers would remove some of the cedar rails from their fences to make a passageway for people travelling through their lands with horse and sleigh, to permit a short cut through their fields to the main road. This was the situation with Grandpa's farm, where Adam and Anna Royal live today, to the fence with Guy Sawyer and then through Mr. Sawyer's yard to Church Street (then called The Church Line Road).

The seniors shared photos, old letters and told stories about family members who went to war.



After a Hard Day's Work

I remember my grandfather always read the Farmer's Almanac and respected omens.

He would never start a job on a Friday. I've seen him do one cut of hay or plow one furrow the Thursday evening for the next days proposed chore.

If the work was done, he would visit Joe Tennier's barber shop on a Saturday afternoon, and then make his way to the Blueroom for cards and several quarts of beer. Sunday mornings were his time to play cribbage with Roy Imhoff



or Lester Flowers. Sunday evenings were often devoted to political discussions or local problems with Mr. Bert Law.

Being an avid card player, when the seasonal work-loads around the farm were more manageable, there were good friends like Cliff and Joanne Flowers around our kitchen table. Their place was full of laughter; and Grandma had a hearty lunch prepared at evenings end. She did not play cards, but enjoyed every minute of these happy times.


