Regional issues tackled at first electoral debate for the Gaspé Peninsula Magdalen Islands riding

SAINTE-ANNE-DES-MONTS - The first debate of the electoral campaign in the Gaspé Peninsula Magdalen Islands riding took place in a relatively calm manner with only a few heated discussions.

The absence of outgoing Liberal Member of Parliament Diane Lebouthillier from this debate on September 2 at the Maison de la culture in Sainte-Anne-des-Monts certainly had an impact on the other participants who had prepared for their attacks on her, since she must defend Justin Trudeau's governmental management in this early election.

Vaccination and climate change created controversy

The absence of Diane Lebouthillier because the can-

didate of the People's Party of Canada, Christian Rioux, is not vaccinated steered the debate on health measures and the freedom of choice.

"The vaccine does not prevent transmission. It has been verified by the CDC (Centers of Disease Control and Prevention). The vaccine does not prevent you from having it

(COVID-19) nor does it prevent it from being transmitted. So what's the point of being vaccinated?" questions Mr. Rioux.

"I am very sorry for the healthcare workers. We are here for you," replied Mr. Bernatchez.

Conservative Jean-Pierre Pigeon criticized the Liberal's

slowness in reacting at the very beginning of the pandemic. He subsequently defended the Conservatives' position on climate change when activists rejected a resolution to this effect during the last session, Mr. Pigeon stated that seven of the ten provincial associations supported the principle.

Christian Rioux denies the impact of humans on the phenomenon of climate change. "I find it unfortunate that people rely on politicians, activists and artists rather than relying on science," says Mr. Rioux.

"Maybe you are not listening to the right scientists," the Bloc candidate told him.

Other topics

Guy Bernatchez evokes a decentralization of jobs to the regions among the measures of his party's platform.

Everyone agrees that the issue of the gantry crane and the Grande-Rivière wintering wharf needs to happen.

The candidates debated for an hour and a half. The debate also included issues of employment, labour shortages, housing and economic vitality.

A few spectators came to listen to the discussions.

Diane Lebouthillier walks out of debate

SAINTE-ANNE-DES-MONTS - Because the candidate of the People's Party of Canada was not vaccinated, the outgoing Liberal Member of Parliament for Gaspésie-Les Îles-de-la-Madeleine, Diane Lebouthillier, refused to participate in a debate organized by L'Avantage Gaspésie and Gaspésie Nouvelles on Sep-

tember 2 at the Maison de la culture in Sainte-Anne-des-Monts

This twist took participants and organizers by surprise as Christian Rioux confirmed that he had not received the vaccine against COVID-19.

"The population has been confined to their homes for a year and a half. We have worked hard to get vaccines and we have a person who is seated in the front who is not vaccinated and who is against the vaccine, there is no question of that," exclaimed Ms. Lebouthillier in the entrance hall of the Maison de la culture, a few moments before leaving the scene in front of spectators who were not aware of what was happening.

Bloc Québécois candidate Guy Bernatchez couldn't believe this stroke of brilliance on Minister Lebouthillier's part. Not wanting to react to the fact, he took part in the debate and made an assumption regarding Ms. Lebouthillier's departure, once the debate was over. "I think it was already planned. It shows a certain fear on her part to face me in a debate. Am I okay with Mr. Rioux not having his Vaxicode? No, because everyone has to do their part," stated Mr. Bernatchez.

"I can understand the departure of Ms. Lebouthillier. It was her choice. For the Conservative Party, it is freedom of choice. Get vaccinated. (...) but people manage their own health. I would have preferred Mr. Rioux to have been vaccinated. I can understand, but it is his choice," stated Mr. Pigeon who was alongside Maxime Bernier's candidate on the debate stage.

The People's Party of Canada candidate justified himself.

"When she arrived she said I had to go or else she wasn't participating. I had to be excluded. I found that unacceptable. I respected the rules that had been established. I respect the rules in force in Quebec," explains Christian Rioux.

The organizers had checked with Public Health: the spectators had to be vaccinated, but


the participants in the debate and the technical platform staff were exempt.

Sixeteen projects to receive \$4.1 million

GASPÉ - Quebec is supporting 16 projects in the region totalling nearly \$4.1 million under the Rural Regions Fund.

Most of the investment will go to the Commission jeunesse Gaspésie-Îles-de-la-Madeleine for the Vivre en Gaspésie Strategy, which is obtaining nearly \$3 million over five years in order to consolidate population growth and contribute to economic vitality.

Present in Gaspé on the afternoon of August 23, the Minister of Municipal Affairs, Andrée Laforest, highlighted the region's efforts in this regard. "In several regions, young people are leaving to go to large centres. Here, it's incredible to see, but at the same time, I congratulate you because you are doing what's needed to keep them here," said the minister.

Among other projects, the Régie intermunicipale de transport Gaspésie-Îles-de-la-

Madeleine will receive \$217,033 to create new infrastructures and develop tools to integrate complementary public transport services, in particular the sharing of vehicles and the establishment of carpooling services and an addi-\$75,000 for sustainable mobility hub involving six sites in each of the MRCs.

Other supported projects

Other significant projects include Gimxport for the Espace régional d'accélération et de croissance de la Gaspésie which will receive \$150,000 to stimulate business innovation and synergy with a support program.

The Prefects Table will receive \$100,000 over three years to support the development of the industrial forest sector and another \$90,000 is planned for the implementation of strategic territorial development planning.

Several projects in recreation, culture, environment, tourism and food will also receive support from the fund. Some of the organizations in those sectors that will receive funding include Les Percéides, CIRADD, the Groupement forestier coopératif Baie-des-Chaleurs, Gaspésie Gourmande, Culture Gaspésie, l'Unité régionale loisir et sport, the GAMME and the Regional Council for the Environment.

The Committee for Anglophone Social Action is also awarded \$25,000 to launch the social enterprise The Gaspesian Way to allow tourists to discover and ultimately access important cultural or heritage attractions within the Englishspeaking community of the Gaspé.

"These are projects that are extremely structured for our region. We targeted seven issues in the Gaspé that we wanted to work on and these projects target those issues allowing the Gaspé to move forward," says the president of the Prefects Table, Nadia Minassian.

SUNNY BANK FLOOD IN 2010:

Judge will make a ruling

GASPÉ - Discussions to reach an out-of-court settlement in the dispute between residents of the Sunny Bank neighbourhood in Gaspé and the Quebec Ministry of Transport following the 2010 floods were unsuccessful.

Hearings began on September 7 at the Percé courthouse for the rest of the appeal.

The exchanges between the two parties remain confidential and cannot be evoked before the court.

From December 13 to 15, 2010, some 246 millimetres of rain fell on Gaspé, causing the York River to overflow on this

The design of the road linking the Sunny Bank and Wakeham neighbourhoods, rebuilt in 1977, is said to be in question. In the application, it was mentioned that this section slowed down the flow of the river.

It used to be a path and when there was excess water the floodplain absorbed it. By 1952 the road had been raised resulting in water getting blocked, but the damage was much less.

The appeal filed in 2013 and authorized in 2015 affects 99 buildings in this sector, to the west of the disputed road.

Why so angry?

The events in the news the last few weeks are not encouraging. Remember climate change? It has been pushed on the back burner just now, but it is still a huge concern for the planet. Not in the future, mind you, right now. Afghanistan has been front and centre and the humanitarian crisis is not over for those still trying to flee the country or those who will be left behind. It is a country in shambles, with rising prices, long lines to buy food and the uneasiness about the Taliban. Do we have our ultimate power at the ballot box on September 20? Do we silence those that disagree with us? Can we be proud of how some Canadians are trying to silence some of the candidates?

In a democracy we all have a say, and that is its strength. The word democracy comes from two Greek words that mean rule by the people. In a democracy we have a say. In a dictatorship one person makes all the rules. Not in Canada. We elect our leaders, and these leaders make decisions about laws. If we don't like some deci-

sions, we can use our voice in several ways. Call your elected representative, write letters or emails to the government, hold up a dissenting sign at a political event, but avoid the "F" word on your sign please. Children can read, but your true power is your vote.

After we vote, the majority rules. The candidate with the most votes wins. What we are seeing in the news with the "very angry protestors" is this. They are taking away my and your right to hear what a candidate says. I want to listen, and hear what questions are asked. The person who is screaming obscenities is infringing on my democratic rights.

Sure, express your displeasure, but do it in a respectful manner. If I recognized someone that I knew prohibiting a candidate from speaking while yelling obscenities, I would be, well, a whole myriad of emotions including shame, confusion and disbelief.

We live in a fantastic country. I do not have to wear a burqa when I go out, my daughters and granddaughters have the right to an education, we have universal health care, and we live in a democracy.

If you do not agree with the current government officials? Vote.

LETTERS TO THE EDITOR

Mrs. Lebouthillier, we request that your government take immediate action and work with VIA Rail to set up a plan to resume passenger train services in stages on the Gaspé Peninsula as soon as possible. Currently our railroad is fully repaired and safe for passenger trains between Matapedia – New Richmond – Caplan.

Technically, VIA Rail could resume passenger train service to New Richmond or Caplan now. We strongly urge that the service should be resumed to New Carlisle as soon as the tracks are ready and the next step would be Chandler which is an important city and has a hospital. Next step would be Percé (tourist capital of Quebec) and finally Gaspé as a last step. Proposed stages for resuming service

- New Richmond or Caplan: now (August 2021)
- the tracks are ready and safe;
- New Carlisle: Fall 2022;
- Chandler: as soon as the tracks are available and safe;
- Percé: as soon as the tracks are available and safe;
- Gaspé: summer of 2025 or before.

Major track maintenance work has been done, the two railroad bridges in Cascapedia-Saint-Jules have been replaced at a cost of \$22.5 million and Caplan bridge fully replaced at cost of \$6 million. MTQ has invested \$80 million so far in repairs.

We have the official confirmation from the Société du chemin de fer de la Gaspésie that the tracks are fully safe for immediate return of VIA Rail passenger service from Matapedia to New Richmond.

Since May 2017 the Quebec government (MTQ) has set aside \$235 million to repair the entire Matapedia to Gaspé railroad. The federal government also contributed \$45,8 million to help repair and protect our railroad from coastal erosion.

Climate change and the actions that need to be taken can no longer be delayed. The latest report from the Intergovernmental Panel on Climate Change (IPCC)1 sounds the alarm for everyone and Canada is among the top three per capita emitters of carbon dioxide in the world.

There are no small gains and the use of the VIA Rail passenger train in the Gaspé Peninsula will contribute to the reduction of greenhouse gases.

The people on the Gaspé Coast are impatiently awaiting the return of the VIA Rail passenger train (which has been missing for eight years). VIA Rail stated at the 2021 annual public meeting that they will return when the railway is fully repaired and safe to Gaspé in 2025.

This is a insult and clearly unacceptable. All Gaspesians needing the train and cannot wait until 2025. The service has to be restored as soon as possible in stages. In 2018, during a visit to New Richmond, former VIA Rail president Yves Desjardins-Siciliano was open to returning in stages, like to New Carlisle first.

With a return of the passenger train service in stages, a RÉGÎM shuttle bus service could provide connecting service to Gaspé, ensuring full service between Montreal and Gaspé.

The people on the Gaspé Coast need VIA Rail passenger train service to travel outside the region for healthcare, visit family, and for people to visit this beautiful region. Traveling by bus or plane is not an option for most people. The bus is uncomfortable with no place especially for seniors to rest. Traveling by plane is far too expensive for most people. The train is the most comfortable and affordable way for most people to travel.

A sum of \$415.8 million has been required by VIA Rail to supplement its funding and its lack of revenue for the fiscal year ending on December 31, 2020, from the Government of Canada. We as taxpayers cannot accept that we have to pay more and have less train service (no service at all in the case of the Gaspe Peninsula).

We need your strong support for the return of the VIA Rail passenger train as soon as possible on the Gaspé Coast. We ask you to contact and plan a face-to-face meeting with your colleague, Omar Alghabra, Minister of Transport of Canada, in order to find solutions and actions to quickly restore the service in stages and to transmit them to the senior management of VIA Rail which does not seem to be able to find solutions for the fast return of the train to the Gaspé Coast. There are 3,427 people on social media who ask you to act now.

We are asking you to publicly declare, with a written response to the signatory of this letter by August 27, your support for the return of the train to the Gaspé and the actions you are taking to bring back the service. We look forward to hearing from you.

investments in the Gaspé and Magdalen Islands, Ms. Roy answered, "We should be interested in all impact companies in the region to have better development and create more jobs and the more we deploy, the more jobs we create, it's true."

A year ago, during the overhaul of Investissement Québec, the government promised more resources in the Gaspé Peninsula while regional management was centralized in Rimouski for Gaspé, Lower Saint Lawrence and Chaudière-Appalaches.

When the court authorized the class action, the citizens' attorney, Marie-Anaïs Sauvé, felt that it would be more than surprising that the installation of the road in the late 1970s had no impact when she watched the staggering increase in residential flooding after construction.

In the petition, it says that after the construction in 1977, buildings belonging to the members of the group were flooded and the water level reached unprecedented heights when the water rose at least 10 times, namely in 1977, 1980, 1981, 1983, 1997, 1999, 2004, 2009, 2011 and 2017.

In an amended petition filed on August 31, which must be approved by the court, a hydrogeological expert notes that the soils are very permeable and the road increases the possibility of water infiltration into the basements of affected residents.

Moreover, because of the loss in the value of the buildings, the plaintiff is claiming a minimum of \$2,137.50 for each of the members of the action.

People are hoping to be compensated for the stress and loss of value of their properties, among other things, and are asking the court to order the Department of Transportation to fix the road.

The person named in the action, Andrew B. Patterson, said in 2015 to have suffered damages exceeding \$250,000 for his properties in the neighborhood.

An amount of at least \$3 million has already been mentioned in the past as compensation.

CAMPBELLTON HOSPITAL:

Mayor of Pointe-à-la-Croix increasingly concerned

POINTE-À-LA-CROIX - The temporary closure of the intensive care unit at the Campbellton hospital is of great concern to the mayor of Pointe-à-la-Croix.

The measure, which is in effect until September 9, was aimed at maintaining emergency services. With more and more recurring service disruptions, Pascal Bujold is asking New Brunswick for more predictability when it comes to Campbellton Hospital, which is the primary hospital for citizens of Avignon West.

"What is the government of New Brunswick's long-term vision for that hospital? If we receive positive feedback, that everything is in place to try to recruit people, that everything possible will be done, that will be okay," says the mayor.

If he does not get an answer, "We will look out for the protection and safety of my citizens. If that means setting up a 24-hour emergency service in Matapedia or Pointe-à-la-Croix, I'm on board! Mr. Bujold says.

The Integrated Health and Social Services Centre of the Gaspé says patients in Avignon benefit from a temporary service corridor to other New Brunswick hospitals, however, they can be treated in Quebec if they wish.

With this new episode of disruption of services at the Campbellton hospital, the member of the National Assembly for Bonaventure is once again bringing the idea of a 24-hour emergency service in Matapedia to the forefront.

Sylvain Roy had mentioned the idea a year ago, especially since the CLSC in Matapedia has facilities that can accommodate a radiology

department.

Mr. Roy noted a degradation of services for Quebecers, which could endanger lives. "The Higgs government's game plan is to strip the supply of services in Campbellton and move it to Bathurst. They've had this in their heads for a long time and they are in the process of doing it," says the deputy, who suggests taking advantage of the reflection on the future of Maria hospital to review the entire offer of services.

"While making a call for tenders to build a new hospital, why not take the opportunity to improve the range of services in Avignon West by adding infrastructure and technical equipment and whatever that takes," says Mr. Roy.





Dr. Linda Dawn Brown family physician and author

SHIGAWAKE: Dr. Linda Dawn Brown, family doctor and author, recently published her first children's book, Finding Us. She is justly proud of this book aimed for six to eight-yearolds, but the inspiration came from wanting to give something meaningful to her two young grandsons, Oscar and Finnian. She wanted to give them, "Something that would stand the test of time."

Just as she does every year, Dr. Brown visited the Gaspé for three weeks this summer. She inherited a small house in Shigawake that her mother bought from the Huntington family when Linda was a young girl. She mentions her family connections: her grandmother Mina Smith (sister of Ida Smith), Neil Hayes, David and Vince

She recalls spending summers here on the Gaspé for most of her life, except for missing a few years when she was studying medicine. She recounts making life-long friends here and spending joyous summer days with her Aunt Madeline and Uncle Malcolm who had who had a house next door and her cousin Barb Silano. Highlights of those summer days were having meals together and spending the days at the beach. Her summer visits provided her with "a freedom I had never known." Her parents were very strict, but when spending her holidays here, her life was a bit different. Dr. Brown remembers riding a bareback pony by herself to the Third Range of Shigawake.

She has made a few upgrades on her wee house in Shigawake, and she continues to return every summer be-



Dr. Brown has recently retired from her busy role as a family doctor with a specialty in obstetrics. She has been an associate professor of pediatrics at Queen's University in Kingston. She tells Spec, "I had a full and active career and loved what I did for over 40 years. I looked around and thought 'I'm healthy now,' so I made the decision to retire."

She did not always have the intent to become a doctor and struggled with the decision to opt for studying the Arts or Sciences at university. Her dad was a surgeon, but it was not until she spent a summer after the final year of high school volunteering in a hospital that her decision was made. Her decision was made to study sciences. She reflects that "It was just the right fit!"

Over the years she has kept an active interest in the arts world, and this has created a balance in her life. One of her passions is dance and she has been a partner in a dance studio for 30 years, cause she feels recharged wrote musicals, and taught French.

path there are "dark things." The friends find their power from their friendship.



Train service becomes an electoral issue

NEW RICHMOND - The Coalition of Gaspesians for the future of trains calls for the intervention of Diane Lebouthillier and the Minister of Transport of Canada to ensure the return of VIA Rail to the Gaspé.

In a letter addressed to the outgoing Liberal Deputy Minister on August 20, the Coalition calls for quick intervention with the federal Minister of Transport, Omar Alghabra, with the goal of finding short-term solutions for the resumption of passenger train service in the Gaspé Peninsula.

The organization notes that Quebec has invested \$80

million so far on the Gaspé railroad and the railway line is safe between Matapedia and New Richmond, which would allow the train to return to this segment. In addition, the coalition is calling for a gradual return to the east as the work progresses.

VIA Rail has always indicated that it will come to Gaspé once the complete and safe rehabilitation of the track has been completed. Quebec is moving forward to 2025 for the end of the work.

The Coalition is receiving support on the issue from the Bloc Québécois. While at a joint outing, candidates Kristina Michaud and Guy Bernatchez both criticized outgoing Liberal member Diane Lebouthillier for her

lack of boldness in this mat-

The lighthouse of Cap-des-Rosiers

The Conservative candidate for the Gaspé Peninsula and Magdalen Islands made sure to include lighthouses in his party's platform.

Patrimoine Gaspésie is asking the candidates to deliver on the Cap-des-Rosiers lighthouse. Without committing specifically, Jean-Pierre Pigeon notes that his party is committed to providing the tools to protect built heritage.

"I have checked with the party and they confirmed that lighthouses will be a very important part of the platform. If I am elected, I will work very, very hard to obtain repairs to the Cap-des-Rosiers lighthouse," says the curator.

Christian Rioux wants to initiate discussion.

The People's Party of Canada candidate in Gaspésie-Îles-de-la-Madeleine isn't hesitating to go against the grain for the September 20 election.

From the outset, Christian Rioux has called the management of Justin Trudeau's debt a disaster, saying that other countries have taken less debt in the management of the pandemic.

Maxime Bernier's candidate wants to remove interprovincial barriers and exploit natural resources, which are being blocked for ideological reasons.

"The regions are getting poorer. We have big problems. Governments don't necessarily do the right thing. Maxime Bernier spoke openly in favour of the development of natural resources," explains Mr. Rioux.

The party wants to balance the budget "Once that's done, lower taxes, etc., that doesn't mean that we're going to cut infrastructure programs. But there are a lot of programs that could be cut," says the candidate, giving as an example the generous subsidies to multinationals like Bombardier.

The candidate is, however, realistic about his chances "My goal is more to promote and stir up ideas, especially when the other parties are all similar," says Mr. Rioux.

Over \$8,000 for the the *Equipage* community social pediatrics centre

GASPÉ - A cyclist from Gaspé biked 7,000 kilometres between Vancouver and Cap Bon Ami, at the eastern end of Forillon Park with the goal of raising \$7,000 for the l'Équipage community social pediatrics centre in Rivière-au-Renard.

Centre director Mona Sirois reported on September 1 that the goal had been exceeded as \$8,125 was raised and donations continued to flow in.

Samuel Girard left Vancouver on June 17. He averaged 120 kilometres per day for about 6 hours per day to complete the trip in 74 days on August 29.

"The most difficult part was Ontario. The roads were difficult. Not much shoulder. There were fewer services too. In terms of water and supplies, it was also more difficult. It's also "the before last" province and you're about to make it home but you still have 2,500 kilometres to pedal. It's not nothing when you can't wait to get there," explains Mr. Girard.

Freshly graduated with a Bachelors in business administration from the HEC Business University in Montreal, he was in a period of life that allowed him to do so.

"Not all families necessarily have the support, sports, social and community opportunities. It's a great way for the community to promote these

values. It's an opportunity for me to give back to the community," explains the cyclist.

The last of a family of seven children, Mr. Girard found it important to do something for the community and he considered the Social Paediatrics Centre to be a very good cause.

"Any dollar, no matter where it comes from, is really welcome. This allows us to offer the services that we have had for two and a half years," says Ms. Sirois who was present when Mr. Girard made a stop on August 28 at the centre before completing his journey.

"Now people are contacting us for fundraising. It's really fantastic," adds Ms. Sirois. The team now has three social workers, a special educator, a pediatrician and a doctor, which necessitates a relocation of the head office to Rivièreau-Renard. A fundraising campaign will take place for the redevelopment, once the move

is completed.

More services will be offered in the territory as workers will travel to schools to offer services to children.

In Gaspé, a room will be found to have a someone there once a week.

On the Grande-Vallée side, the centre hopes to have a drop-off point to hold activities one day a week.

The ultimate goal is to open service points in Murdochville and Barachois. In the latter case, this satellite office would make it possible to better serve the English-speaking clientele.

Four new COVID-19 infections

GASPÉ - Five new cases of COVID-19 occurred in the Gaspé Peninsula and Magdalen Islands between August 27 and September 4.

Two of these cases were registered on August 27, two on August 28 and one on September 4.

Four cases remained active on September 4.

The Micmac government in Listuguj reported late August 27 that one of these cases was in the community and that everyone in contact with that individual was tested and received negative results. A screening clinic was organized on August 28 and 29 at the Pointe-à-la-Croix CLSC. A Listuguj community member in his early thirties died on August 13 after being infected According to that government, he was not vaccinated.

In August, 14 cases occurred in the Gaspé Peninsula and Magdalen Islands, half of which were in the MRC d'Avignon. There were three in Bonaventure and on the Côte-de-Gaspé and one in Haute-Gaspésie.

Since March 20, 2020, 2,090 cases of COVID-19 have been recorded in the Gaspé Peninsula and Magdalen Islands.

As August 28, the number of fully-vaccinated individuals in the region (Gaspé Peninsula and Magdalen Islands) reached 75.5%. For the Gaspé Peninsula alone the number was slightly lower at 74.2%. That number is up from the August 22 weekly report when the rate was 73.6%.

The MRC d'Avignon is still lagging behind at 65.7% as it struggles to cross the bar of two-thirds of fully vaccinated citizens.

The region continues to do better than the provincial average of 70.2%.

Saltwater and salt mining

Water covers two-thirds of the Earth's surface and 97% of that is salty seawater. If you have ever swallowed a mouth full of saltwater when swimming, you will know that it is not tasty although a small amount will not harm you. Survival manuals advise against drinking seawater and statistics prove this. The risk of death for people lost at sea who drank sea-

water is 40% and for those who did not, the risk is only

Desperate sailors who have no fresh water supply left on their vessel try to capture rainwater. The poem Rime of the Ancient Mariner which contains the often quoted "Water, water everywhere and not a drop to drink" famously sums up the dilemma of obtaining drinkable water at sea. Some large oceangoing ships have reverse osmosis and distillation equipment which can provide potable water by treating sea-

Animals have adapted to living in saltwater and some, such as sea turtles and saltwater crocodiles, remove the excess salt in their bodies through their tear ducts.

Where does the salt in the ocean come from? Rain falls on rocks and dissolves small amounts of mineral salts from the rocks, including sodium and chloride. The salt then enters the water of streams, lakes

and then flows into oceans. Sodium chloride is the main ingredient in salt in seawater, and the very same salt you use to season foods.

The salt in the oceans has been built up over billions of years. The salt also comes from hot vents on the ocean floor and from volcanoes on land or sea. Salt is always flowing from the land into the sea and in warmer, tropical waters

there is more evaporation due to the heat, so the water is saltier.

Towards the poles, north and south, the melting ice dilutes the water so it is less salty.

"Water, water everywhere

And not a drop to drink."

But wait! Climate change is here, and this will affect all ecosystems on the planet. As the climate warms, there will be more rain and melting ice in the northern hemisphere and more evaporation in the southern hemisphere. This will change the saltiness of the oceans. When the water is saltier it becomes more dense and therefore heavier. This will affect how water moves in the oceans and ultimately all life on Earth – not just the ocean creatures.

Ocean salinity (the amount of salt in the water) has been the same for millions of years. Now it is changing.

Magdalen Islands

The Magdalen Islands are floating on enormous salt supplies called salt domes. In fact, the only salt mine in Quebec is

located on the Islands. One area of huge deposits is located under Grosse-Île, and rock salt has been mined there since 1982. The road salt for deicing winter roads on the Gaspé is transported by ship from the Islands. This huge supply of salt is mined at a depth of 300 metres in tunnels that extend over 1.6 km under the dunes and the sea. It is estimated that the mines will supply salt for another 30 years.

A little taste of Quebec: Seasonings from nature

A quick look in the spice cupboards reveals salt, pepper and peppercorns, Montreal steak spice, garlic, lemon pepper and summer savory. We all tend to use the same spices over and over. Quebec produces some locally harvested and foraged plants that are used to make spices that are a little different. They are worth trying because you just might like it! Some of the products may seem a tad pricey, but for these spices, a little goes a long way.

Quebec Herb blend

This blend is made entirely from herbs harvested in Quebec. Reputedly, our ancestors created these blends and used them in all types of recipes. It incorporates onion, parsnip, savory, thyme, shallot, parsley, celery leaf, marjoram, tarragon and celery seed. It can be used in such recipes as stew, baked beans, pork roast, turkey and on fiddleheads.

Sumac

In the Middle East sumac is



used to add a hint of sourness, as you would use vinegar or lemon. You can use it with grilled meats or vegetables, hummus and salad dressings. The slight sour taste is a wonderful pairing with seafood and fish. This shrub produces red berries, and the entire berry is crushed gently, including seeds which are edible. NOTE: Do not pick your own sumac berries unless you are very knowledgeable about the plant. Some varieties are poisonous.

Rose petals

The rose petals, from the region of Lac St. Jean, are harvested by hand and then dried. The petals are from a specific, rustic variety of rose which has a deep colour and is very aromatic. The dried, crushed petals can be used as a flavouring in desserts, and they pair well with ice cream and fruit salad. It can also be used, sparingly, in lamb, rice or poultry dishes.

Thyme

This plant is picked at the end of the growing season as the nights are getting cooler. Thyme is a hardworking flavouring because it can be used in so many dishes. Use with roasts, stuffing, omelets, vegetables and more! The thyme grown in Quebec is noted for its intense flavour, so use a little to begin with and add from there according to your tastes.

Tarragon

Tarragon is a less common spice due to its strong and slightly bitter taste. It has a flavour reminiscent of black licorice, so use very sparingly because its flavour can overpower your recipe. Use it in salad dressings, soups, potato salad and meat pies.

Spice Hunters' Quebec blend kit

For those cooks who wish to embark on a Quebec spice adventure, you can purchase a box with four different spices. One product includes Montreal spice rub, Tourtière spices, Nordic Zaatar and Gaspesian salmon rub. Nordic Zaatar is a unique creation of traditional Zaatar from the Middle East with the addition of dried herbs grown in Que-

To buy these spices, check in specialty shops, bakeries and grocery stores. You can order online from Gaspésie Sauvage Spice trekkers.com.
